The qualification period for the 2024 EAHGC are the European breeding seasons of 2020, 2021 and 2022, which includes all foals born from 01 January 2021 to 31 December 2023. I acknowledge that the ineligible horse will be disqualified from competition and the awarding of prize money, and that ALL horses exhibited by any owner who willingly falsifies entry information will be disqualified from EAHGC competition for five (5) years.

I also understand that any owner who enters and exhibits an ineligible horse, i.e. one which does not meet entry conditions/restrictions or any overqualified horse, will be subject to penalty of €600.
